2. Approval of the agenda items

3. Approval of June 16, 2017 meeting minutes

4. Principals report

- Orlando Science Middle & High Schools Principal; Mr. Yalcin presented his report to the board members. He highlighted the items below:
 - OSS will have 28 Instructional, 10 Support Staff and 486 students in grades 7-12 at our Lynx Lane campus.
 - 2017-18 school year pre-planning was held on August 7th -11th.
 - OSS had Summer Institute professional development for beginning and first year teachers. Five OSS middle/high teachers participated in this teacher preparation program.
 - The school year for students started on Monday, August 14th.
 - The following important events and activities were held at the school.
 - Orientation Day was held on Saturday, August 12th.
 - On August 18th, Mr. Moon, one of our math teacher at Orlando Science Middle High was honored by the Mathematical Association of America (MAA) in August with the Edyth May Sliffe Award for distinguished mathematics teaching at the middle and high school levels.
 - FIRST FTC and FRC Robotics Parent Day was held on Saturday, August 26th, 2017.
 - Curriculum Night was held on Tuesday August 29th, 2017 for Grades 7th -12th
 - On August 30th, Orlando Science Middle High received the formal certification of Accreditation from the Southern Association of Colleges and Schools Council on Accreditation and School Improvement (SACS CASI), an accreditation division of AdvancED. This action was taken at the AdvancED Accreditation Commission meeting held in Orlando, FL on April 10th, 2017. Orlando Science Middle High has been accredited since 2011.
 - Saturday September 23rd, 2017: Orlando Science Middle High held its annual welcome picnic.
 - In 2017-18 school year, OSS Middle/High is excited to offer five additional AP classes: AP American Government and Politics, AP Macro Economics, AP Environmental Science, AP Computer Science A, and AP Psychology.
- Seminole Science Charter School Principal: Mr. Aksu presented his report to the board members and highlighted the below topics:

- SSCS started the school year with 498 students and 45 staff members.
- SSCS received an "A" school grade by DOE based on 2016-17 FSA scores.
- SSCS didn't have any major damages after the hurricane Irma, but some minors.
- SSCS will host its first VEX Robotics Competition on Saturday October 21th. The school is working together with Northeastern State University in Oklahoma. Director of NSU robotics program and 5 college of education students will come to visit a week as their internship program and they will also help SSCS to host this competition. They will also observe SSCS teachers during the week of October 16th.
- Osceola Science Charter School Principal; Mr. Cetin presented his report to the board members. He highlighted the items below:

- Hispanic Heritage Night Planned and will be held at OSCS on October 12, 2017.
- Osceola County School District will update the school calendar after Hurricane Irma recovery.

5. Executive Director report

Dr. Akin reported on over all campus updates. He stated that this is our 10th year in operation in Orange County. Our school system grew from 100 students around 2,200 students. Currently, we are operating 4 charters in 5 campus buildings. Orlando Science High School building and Osceola Science Charter School K-8 campus construction projects are progressing very well with Building Hope.
